August 2023 search for an account executive for WJJB/WPEI Atlantic Coast Radio

Recap:

Commencing on 7/31. WJJB ran 35 thirty second spots weekly on WJJB, WPEI, AND WLOB looking for an account executive. A total of 140 spots per station were run on a 24 hour plan. We requested resumes emailed to Sales Manager Morgan Grumbach. In addition, we ran a Craigslist advertisement and sent out a notification to our community contact list.

We received nine resumes from the advertising. Six responded from the radio advertisements, three from the online advertising. Morgan conducted five preliminary phone interviews. We decided that three applicants merited an in person meeting. One person was a no show. We had two candidates that we interviewed twice, the second time with Morgan and GM Jon Van Hoogenstyn.

We determined that the comp package that they had with their current employer exceeded what we were prepared to spend for someone without prior media sales experience. We did not find a match, so to speak.

We plan on running a virtual job fair in November and we may have better luck.



EEO 2023 ATLANTIC COAST RADIO JOB FAIR RECAP

We decided to run this year's job fair as a virtual event, due to the recurring low grade spread of Covid 19 and the flu. Potential participants were required to send us a resume in advance in order to get an appointment. Ads were run in Craigslist. Fifty spots were run over a ten day period from October 28 through November 6th on all three of our formats. I think the results were very good.

We had four participants the day of the job fair, which was on Wednesday, November 8th. One participant was a person who had some limited experience doing broadcast traffic and was looking for part time work. Another was a recent college graduate who had college radio experience and was looking to moon light in sports radio part time. Same for participant three who had less experience and needed to develop a demo tape. Finally, we interviewed an individual with extensive media sales experience at the station and agency level. So, there were legitimate candidates who participated. Two were drawn in by the on line ad, two were responding to the radio campaign.

There may be some opportunities with a couple of the participants.
